- 3 badges for use once Health & Safety Plan is checked against Ministry of Health, Worksafe and WTTC COVID Health Guidelines
- The WTTC Safe Travels stamp is now being used in 400 destinations worldwide.
- Currently applicable for ITOs, accommodation, activity/attraction and transport operators plus restaurants, bars, cafes



What is the difference between TTC and Covid Clean?





Both initiatives have health protocols that meet Government (Ministry of Health and Worksafe) and allow a business to display the WTTC Safe Travels stamp. The key difference is who can see the information and the influence it can have on your business being booked by ITOs and offshore wholesalers and agents.

The Tourism Trade Checklist, formerly known as TECNZ's Health & Safety Checklist, is the 'go-to' place for ITOs and offshore trade when sourcing all business compliance information for tourism operators.

The Aim

The aim of the new platform is to promote tourism operators who comply with New Zealand's Regulations and who have a COVID Health & Safety Plan. In particular, to demonstrate you are COVID-Ready to host visitors. In the future there will be increased demand from international visitors and offshore clients for suppliers and ITOs to demonstrate health and safety is a priority in the business. The checklist allows operators to easily upload their information to a directory, which is then accessed by ITOs. Any supplier working with ITOs will be strongly encouraged to sign-up to the Checklist so there is confidence for ITOs to include your business in future itineraries.

The Tourism Trade Checklist is the same as what ITOs and tourism suppliers are using in Australia. This will be helpful when both countries reopen their borders. It will allow us to remain competitive but also to provide reassurance for any traveller planning a dual destination trip. Our thanks to ATEC for their support and willingness to partner with TECNZ on this initiative.

WTTC Safe Travels Stamp

Once you have submitted all documentation including a COVID Health & Safety Plan, your business will receive two badges and a World Travel & Tourism Council (WTTC) Safe Travel stamp. Logos can be used on email signatures, websites and any other communication tools you might have.
